A RESOLUTION OF THE DUNCAN TOWNSHIP MUNICIPAL WATER AUTHORITY, TIOGA COUNTY, PENNSYLVANIA, AUTHORIZING THE SELECTION, APPROPRIATION, AND ACQUISITION OF PROPERTY BY CONDEMNATION FOR LOCATING. INSTALLING. CONSTRUCTING, RECONSTRUCTING, EXTENDING, REPAIRING. REPLACING, MAINTAINING, AND/OR ADDING NECESSARY FIXTURES, EQUIPMENT, PIPES, BUILDINGS, AND APPURTENANCES THERETO; AND AUTHORIZING THE FILING OF A DECLARATION OF TAKING AND ALL NECESSARY ACTION FOR THE ACQUISITION THEREOF.

WHEREAS, the Board of Duncan Township Municipal Water Authority, Tioga County, Pennsylvania, has negotiated with a property owner to try to acquire the necessary property interests, but has been unable to reach an agreement; and

WHEREAS, in order to carry out the purpose to locate, install, construct, reconstruct, extend, repair, maintain, replace, and/or add any and all necessary fixtures, equipment, pipes, buildings and appurtenances thereto, it is necessary that the Authority acquire title in fee simple to property described herein.

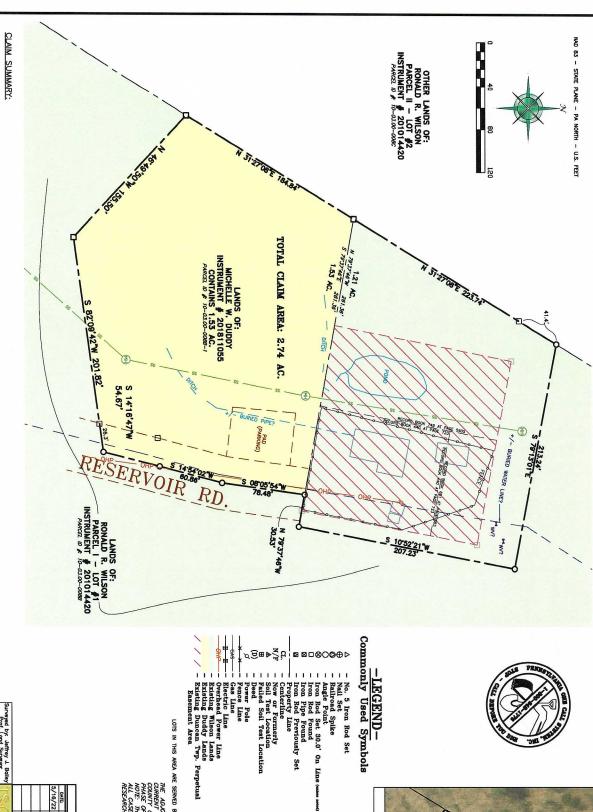
NOW, THEREFORE, BE IT RESOLVED and ENACTED, by the Duncan Township Municipal Water Authority, Tioga County, Pennsylvania, in lawful fashion duly assembled, as follows:

- 1. The foregoing recitals are incorporated herein by reference.
- 2. It is hereby determined that the property herein described, existing within Duncan Township, is necessary to locate, install, construct, reconstruct, extend, repair, maintain,

replace, and/or add any and all necessary fixtures, equipment, pipes, buildings and appurtenances thereto, and that the property should be acquired by the Authority for the fair market value or such value as may be determined by the Board of Supervisors by Resolution.

- 3. The property and owner are identified in the map attached hereto as Exhibit "A".
- 4. The Chairman of the Board and the Secretary are hereby authorized, empowered, and directed to negotiate for and on behalf of the Authority with the owner of the property for the purchase of the necessary rights for the property.
- 5. In the event that the officers of the Authority are unable to agree with the owner of the property as to the purchase price, then title to and possession of the property shall be acquired by the Authority through condemnation, and Cox, Stokes & Lantz, P.C., are hereby authorized, empowered and directed to institute proceedings in the Court of Common Pleas of Tioga County to acquire title to and possession of the necessary property in accordance with the Eminent Domain Code of the Commonwealth of Pennsylvania.
- 6. All resolutions or parts of resolutions inconsistent herewith shall be and are hereby repealed.
- 7. The provisions of this Resolution are severable. If any provision, sentence, clause, phrase, section or part thereof shall be for any reason found unconstitutional, illegal or invalid, such unconstitutionality, illegality or invalidity shall not affect or impair any of the remaining provisions, sentences, clauses, phrases, sections or parts thereof, but the same shall remain in effect. It is hereby declared to be the intent of the Authority that this Resolution shall stand notwithstanding the invalidity of any part included herein.
