

**RESOLUTION NO. 1-2024**  
**OF THE DUNCAN TOWNSHIP MUNICIPAL WATER AUTHORITY,**  
**DUNCAN TOWNSHIP, TIOGA COUNTY, PENNSYLVANIA.**

**WHEREAS**, the Duncan Township Municipal Water Authority, Duncan Township, Tioga County, Pennsylvania, adopted a Resolution on March 18, 2024, establishing basic regulations for the operation of the water treatment facility setting a monthly service charge and usage fee for Equivalent Dwelling Unit (EDU) used; and

**WHEREAS**, the Duncan Township Municipal Water Authority, Duncan Township, Tioga County, Pennsylvania, desires to raise the monthly service charge and usage fees for each EDU;

**NOW THEREFORE, BE IT RESOLVED** that:

Section 1. The amount of service charge for each EDU is hereby amended to read as follows:

For each Equivalent Residential Dwelling Unit (EDU), as hereinafter defined, a monthly service charge of THIRTY-FIVE and 00/100 (\$35.00) DOLLARS shall be due and payable on the first business day of each month. Each residence, commercial facility or apartment is equivalent to one (1) EDU.

For each Equivalent Commercial Facility, as hereinafter defined, a monthly service charge of FIFTY and 00/100 (\$50.00) DOLLARS shall be due and payable on the first business day of each month. Each residence, commercial facility or apartment is equivalent to one (1) EDU.

For each Equivalent Dwelling Unit (EDU), as hereinafter defined, a usage fee of THREE and 50/100 (\$3.50) DOLLARS per thousand gallons of water shall be due and payable on the first business day of each month. Each residence, commercial facility or apartment is equivalent of one (1) EDU.

A five (\$5.00) dollar penalty is imposed if the monthly service charge is not received by Duncan Township Municipal Water Authority by the twentieth (20<sup>th</sup>) day of each month.

Section 2. Said Resolution shall become effective as of April 1, 2024.
